CROPS

Approximately, 41.08 acres of Chandler Walnuts planted from 2011 - 2015. The trees are professionally managed and are irrigated with micro-sprinklers and have flood valves for irrigation as well.

SOIL

According to USDA California Revised Storie Index Grade 1 and 3 soils; see attached soils map for description.

WATER & IRRIGATION

This entire ranch lies within the boundaries of and receives surface water from Last Chance Water District with the main channel of the canal bordering the west end of the property. There is a lift pump in the district canal. There is 1 deep well and 2 shallow wells, a booster pump, sand media filters and single line micro-sprinkler system. Flood valves can also provide irrigation with district water when available and well water.

SGMA

The Sustainable Groundwater Management Act passed in 2014 requires groundwater basins be sustainable by 2040 and requires Groundwater Sustainability Plans (GSP) by 2020.
