

LOCATION

The subject property is located on Highway 41 at Lacey Blvd in Lemoore, 19299 Lacey Blvd Lemoore, CA 93245. The subject property is located just a few minutes to the north of the growing city of Lemoore in a great location for future development.

DESCRIPTION

This opportunity is 80 acres of open farmland. The property has an irrigation well, and there are 80 shares of Lemoore Canal Stock with access to Lemoore Canal for surface water. The current assessor's map shows one parcel however there is a parcel split pending. The parcel split will create 2 forty acre parcels which would be available for purchase either separately or together.

CROPS

The subject property is currently planted to a winter wheat crop. The subject property is suitable for a variety of row crops or field crops.

SOIL

According to USDA California Revised Store Index the subject property consists of mostly Grade 5 soils with some Grade 1 soils; see attached soil map for description.

WATER & IRRIGATION

The subject property has 1 irrigation well and 80 shares of Lemoore Canal Stock are included. The subject property has been historically farmed to row crops. The crops are flood irrigated.

SGMA

The Sustainable Groundwater Management Act passed in 2014 requires groundwater basins be sustainable by 2040 and requires Groundwater Sustainability Plans (GSP) by 2020. GSPs may limit the amount of well water pumped.










SOILS MAP
