LOCATION

DESCRIPTION

This opportunity is 45.65 +/- acres on 1 parcel that can be divided into smaller parcels in accordance with the Kings County zoning.

CROPS

This entire ranch 45.65 +/- acres is planted to mature walnuts. Most or all of the acreage is ready for removal. The grade 1 - excellent soils would be suitable for a variety of row crops or permanent plantings.

SOIL

According to USDA California Revised Storie Index, the soils are Grade 1 - Excellent. See attached soils map for description.

WATER & IRRIGATION

The walnuts are flood irrigated using the wells on the ranch. There are four (4) shallow wells equipped with 5 - 7 horsepower motors. Well depth ranges from 60-70 feet.

The subject property is located in Kings County Water District and part of Mid-Kings River GSA. The property does not receive any surface water deliveries at this time.

SGMA

The Sustainable Groundwater Management Act passed in 2014 requires groundwater basins be sustainable by 2040 and requires Groundwater Sustainability Plans (GSP) by 2020. GSPs may limit the amount of well water pumped.
